

CLARIFICATION ON MINUTES OF MEETING 12th May 2024

1. Firstly, it is categorically highlighted that the meeting held on 12th May cannot be notified as GBM, as this was clearly mentioned during the meeting that GBM was illegal. It can be considered as a meeting of the Alumni for the discussion of various matters.
2. On 04 April 2024 Vice President of RECAA on his post in the WA Groups proposed to immediately dissolve the Association with a request to form new Alumni Association. He also assured that they will extend all the support to the new body. It was also supported by other office bearers. This issue was discussed in detail in the meeting, and it was highlighted that a new association is being formed due to noncompliance of statutory requirements of the Association. It is further highlighted that Ad-hock Executive Body (AEB) has been constituted after due deliberation amongst the Alumni and all actions have been shared with the Alumni in the groups. It is pertinent to mention here that almost all Office Bearers of old Association have been incorporated in the AEB. It was informed that Constitution/ Byelaws, Roadmap etc of the new Alumni Association has been discussed in detail amongst Alumni and shared in the groups.

Now at this stage when new AEB has been formed, registration of new Association is in the process, opening of bank account will be done after registration, formation of various sub-committees is almost in final stage (willingness of interested alumni has been asked through MoM dt 19th May2024), backing out by the office bearers of old Association from their previous decision to form new Association may not be in the interest of the College and Alumni.

3. It is further intimated that, it is repeatedly being said that some Alumni are criticizing the old Association and asking for legality. Whereas fact is that asking legal status, annual reports etc by the senior Alumni was the positive suggestion and it was in the interest of the Association to complete its legal obligations. But this suggestion was taken as criticism.
4. Discussion was held for the celebration of HIRAK Jayanti of the College. It was discussed that combined efforts be made by including new energy of the young Alumni with old experience together to make the HIRAK Jayanti a Grand Celebration. Later, it was assured by the office bearers of old Association to give

support to the new body for the HIRAK Jayanti Celebration in the WA groups also.

5. Most of the points discussed during the meetings have not been mentioned in the MoM 12th May 2024. Nothing was concluded in the meeting. Because no any proposal was put up or proposed, nor any consent/ vote of those present offline/online was obtained.
6. Regarding, decision mentioned in the MoM of 12TH May, these points were not even discussed during the meeting.
7. Finally, it can be summarized that; efforts should be made by all the Alumni to work together for the betterment of the College and the students by utilizing the experience of the senior Alumni and energy of young Alumni. Grand HIRAK Jayanti Program should be organized and all other activities to support the student i.e. Skill Development, Internship, Placements etc. be planned by the Alumni.
